
**7.II. Resolution to Levy 2016 Taxes**


On a motion by Commissioner Jackson and seconded by Commissioner North, the Commission voted 6-0 (Anderson absent) to *approve* the resolution to Levy 2016 Carroll County (8.349 mills, except for the City of Carrollton which is 7.012 mills), and Carroll County Schools (18.001 mills) property taxes for a total Property Tax Levy of 26.35 mills, and adopting the 2016 Homestead Exemptions.
