❖ **Review of items for the May 1, 2018 BOC Meeting Agenda**


The following agenda items were reviewed and discussed:

9. II. Proposed FY 2018-2019 Budget  
 Leamon Stephens, Finance Director stated that there would be a presentation of the proposed FY 2018-2019 Carroll County Budgets at the Board of Commissioners May 1, 2018 Meeting.
9. III. Auction of County Property  
 County Attorney, Stacey Blackmon presented for consideration a resolution to authorize the sale of County property by entering into a contract with Hagen Realty Group to conduct the auction of property.
9. IV. Cold Planer Purchase – Public Works Department  
 Public Works Director, Charles Pope presented for consideration the purchase of one (1) 48" Cold Planer attachment for Skid Steer Loaders for the Public Works Department. Mr. Pope recommended Yancey Brothers Co. at \$27,160.
9. V. Replacement Truck – Public Works Department  
 Public Works Director, Charles Pope presented for consideration the purchase of one (1) used 2011 Freightliner Cascadia 125 from Jordan Truck Sales, Inc. for the discounted price of \$32,000 for the Public Works Department.

9. VI. Integrated Criminal Justice Case Management System  
Clerk of Court, Alan Lee and Superior Court Judge, Dusty Hightower presented for consideration proposals for an Integrated Criminal Justice Case Management System to improve automation of workflows, data collection, interagency communication, court filing and document access needs within the Carroll County Criminal Justice Community. Mr. Lee and Judge Hightower recommended GreenCourt at \$525,000 with no annual maintenance fee in exchange for Carroll County being their showcase client.

County Attorney, Stacey Blackmon presented for consideration a resolution to begin the process of abandoning portion of Wildwood Lane Right of Way lying in Land Lot 164, District 5 of Carroll County.
