APPROVAL OF AGENDA

The June 22, 2021 Agenda was unanimously **approved** as presented on a motion by Commissioner McClendon and seconded by Commissioner Lee.

6. FINANCIAL SESSION

6. I. **FY 2021 Budget Amendment**

On a motion by Commissioner McClendon and Seconded by Commissioner Reynolds the commission voted 7-0 to **approve** the advertised FY2021 Budget Amendment to increase the General Fund Estimated Revenues in the amount of \$6,924,242 and increase the General Fund Appropriations in the amount of \$6,924,242. The amendment will increase DATE Fund Revenue in the amount of \$2,934 and increase the DATE Appropriations in the amount of \$2,934. This amendment will also increase E-911 Fund Revenue in the amount of \$125,465 and increase the E-911 Appropriations in the amount of \$125,465. This amendment will increase Solid Waste Revenue in the amount of \$6,867 and increase the Solid Waste Appropriations in the amount of \$6,867. Any expenses earmarked in this amendment and not expended by June 30, 2021 will be placed in committed fund balance.

7. ADJOURNMENT

There being no further business to come before the Commission, the same was adjourned at 4:06 p.m. on a motion by Commissioner Lee and seconded by Commissioner McClendon.
